WE SHARE THE RESULTS OF OUR LATEST CLIENT SURVEY

Over 30% of our contractor clients – on par with last year's survey results - shared their views on the state of the contractor market and what their next steps are for the future. Our new IR35 section provides a strong insight on the postponed changes to the private sector roll out.

IR35 was a key focus in this year's survey. Results were collated prior to the Covid-19 outbreak and several weeks prior to the 2020 private sector roll out being postponed to April 2021.

This insight gives a strong snapshot on the future of IR35 and the stance of the limited company community.

With this survey completed several weeks prior to the initial IR35 private sector roll out, I feel these results show a true reflection on contractors' thoughts and feelings towards the market.

With so many clients still actively choosing to contract in order to accommodate their lifestyle, it comes as no surprise that greater flexibility is still the number one reason for leaving the world of office politics.

More importantly, rates appear to be on par with last year's results, which we hope will continue.

Based on feedback, we made IR35 our prominent topic for 2020. Over three quarters of our clients are still deciding on their options or still choosing to use their limited company.

We feel the delay gives ample opportunity for the end clients/recruiters to have a greater understanding on IR35 and avoid losing their key talent. Now with the impact of Covid-19 this is more important
